## **SCHOLARSHIP**

One person wanted an application - Jewel has application blank now; needs to know who needed the application.

Scholarship amount is currently \$300, Jewel Wright suggested increasing it to \$500. Arlie mentioned that the Bylaws provide for this to be a self-sustaining fund wherein interest-only is what is used. Jewel moved to raise from \$300 to \$500 effective for 1995.

Eivor Pfannkuch seconded it. Eleanor mentioned donations to the Scholarship Fund. We received \$500 in donaions in '94. Fund was formed for any type of school, business, trade - doesn't have to be college. Parents must be members but child doesn't have to be a member to receive scholarship.

Motion to increase scholarship to \$500 carried (unanimously)

## **UNFINISHED BUSINESS**

**Dues-Increase committee** met (Arlie spoke) - Betty Schoepf researched last year's records. Grand Lodge assessment going up \$3.00. Last year's fixed expenses were \$2680; rent \$885, newlsetter \$591, variable - \$510 for prog. books; misc expenses \$1909.00. Total \$6005.00. \$3,737 in advances. \$1506 profit.

Two events lost money: Crayfish Party \$200.00 Glogg, \$56.00.

Income: dues \$3544. Fund raising \$2475. \$6019 total. \$14:00 ahead!!

Possible charge for Crayfish Party this year to make up for possible deficit. Also, possible increase in Bar charges. Mother's Day Dinner - maybe charge everyone, rather than just men.

Pea soup dinner - \$330 more than previous year.

### **UNFINISHED BUSINESS (Continued)**

Would still have a deficit - recommend \$4.00 dues increase -- Arlie moved to increase dues to \$18.00 per year and eliminate Kurt Pfannkuch's Associate Member proposal. Kurt withdrew his proposal (motion) and seconded Arlie's motion. Would start in July (\$2.00 for remainder of year).

Audrey mentioned that we don't have a set budget and hopes that we have a standing budget committee and that we stick to it, rather than going meeting to meeting at whim of person in

charge of events.

Kurt mentioned that increase is based on a budget - dues increase should be effective upon

passage.

Art Niemoller mentioned that this is a non-profit organization and that we should decide what surplus is going to be used for before we raise dues without a long-range plan.

Audrey pointed out that we could lose non-profit status with IRS due to this surplus.

Marianne Ek suggested possible parties to use some of it up.

# Motion passed to increase dues. From March 3, 1995, all dues are \$18.00

**April Anniversary Dinner** - Ethyl Johnson has been checking on BBQ - Texas Barbeque will bring their wagon to Lodge, set up tables, supply plates & flatware. 3 different meats brisket, pork ribs and chicken -- no sauce, you put it on. Beans and potato salad, coleslaw and corn bread \$11.58 per person - all you can eat. Leftovers remain with Lodge.

We will need reservations.

Lodge will furnish drinks.

Anniversary cake to be provided.

Arlie moved to plan on \$5 & \$6.75 - seconded by Henry Hiersman.

Kurt clarified that the subsidized price is for paid-up members. Others pay full fare.

Texas BBQ needs 5-days advance notice of number of dinners.

Motion passed for Lodge to pay \$5.08 toward cost of meal for each paid-up member
