We are sorry to hear about the death last November of our member Ivy Bland.

When you visit Sweden or almost any foreign country including Canada, you will encounter the metric system of weights and measures. Most of us find it confusing at first. When we introduced a couple simple metric exercises such as estimating the weight of a watermelon in kilos and grams and the length of a sausage in centimeters, many complained it was impossible. Actually, the metric system is simple and logical, that is why it is used in most of the world.

The basic unit is the meter, which is one ten millionth of the distance from the equator to the north pole. The meter is divided by one hundred into centimeters and further divided by ten into millimeters. In the other direction, one thousand meters equals one kilometer.

Area measurement is similar, the square millimeter, the square centimeter and square meter. Ten thousand square meters equals one hectare.

Weight is also based on the same principle. One cubic centimeter of water weighs one gram. One thousand grams equals one kilo. Liquid measurement is similar. One thousand cubic centimeters (cc) equals one liter. In recipes you will find measurements of a deciliter (dl) which is one tenth of a liter, and centiliter (cl) one hundredth of a liter.

The simple metric system is only confusing when we attempt to translate to the complicated English system which we use. However, we are living in an increasingly metric world. If you own a japanese, German or Swedish automobile, you will find the need for metric wrenches. Wine and liquor bottles are now metric. Even the two liter soft drink bottle is now familiar. Engine displacements are now given in liters instead of cubic inches.

Metric equivalents of our familiar measurements are found in most dictionaries and other reference books. It should be easy to remember that a meter equals 39.37 inches, therefore a centimeter is just about two fifths of an inch. There are 454 grams to a pound. A liter is just a little over one quart.

Canada and New Zealand have recently successfully moved to the metric system. It is not impossible. The metric system is even in common use in part of the US. The metric system was in use in Spain when Puerto Rico belonged to that country. It has continued now that it is a commonwealth of the United States.

Be it RESOLVED THAT Article 17 (a) of the By-Laws of the District Lodge Golden Gate No. 12 be emended to read as follows:

The District General Fund shall receive its income from a per capita tax, the amount to be established by the annual District meeting in session, plus any assessments levied by the Grand Lodge, to be paid yearly by the Local Lodges at the close of the term. Al surplus funds received form festivals and other affairs under the auspices of the District Lodge shall be paid into the District General Fund unless otherwise directed.

Motivation: This amendment allows each District meeting in session to determine the per capita tax for the ensuing year; more accurately reflects the wishes of members of the District; allows more flexibility in responding to changing economic conditions and mandates of the District; and eliminates the need to alter the By-Laws each time a change becomes necessary. This change also makes the By-Laws of the District Lodge Golden Gate No. 12 consistent with the Grand Lodge Constitution and By-Laws.

RESOLUTION NO. 1:

Article 24 - ANNUAL SCHOLARSHIP be amended from:

Section (a) no. 3 - The Executive Board will examine all scholarship applications in order to satisfy themselves that rules governing length of membership, high school grades, and general scholastic requirements are followed.

Section (a) no. 5 - Upon recommendations of the judges, the Executive Board shall make the final decisions and have the District Secretary make the official announcement to the winner, as well as to the secretary of all local lodges. All applicants for scholarship shall be notified concerning the results of the contest al early as convenient, giving the name of the winner.

Section (b) no. 1 - The Scholarship is intended for young people entering an institution of higher learning, including a vocational school (college level), and who are enrolled for a fulltime program.

Section (b) no. 4 - The candidate must submit with the application, a complete record of the high school grades, including first half of the senior year.

Section (b) no. 5 - The highest qualified candidate will be awarded the sum of \$300.00 as scholarship which will be payable to a college, university, or vocational school of the candidate's choice.

Be it RESOLVED that the Annual Scholarship be amended to read as follows:

Section (a) no. 3 - The Executive Board will examine all scholarship applications in April, in order to satisfy themselves that rules governing length of membership, transcripts, and general scholastic requirements are followed.

Section (a) no. 5 - Upon the recommendations of the judges, who shall consist of two non-Vasa educators, the Executive Board shall make the final decisions and have the District Secretary make the official

RESOLUTION NO. 7:

Article 22, General Rules (j)

The local lodge Secretary shall notify the District Secretary when the VASA VISITOR is received, and when and where the lodge receiving the VASA VISITOR will take it.

Be it RESOLVED THAT Article 22, General Rules (j) of the By-Laws of District Lodge Golden Gate No. 12 be amended to read as follows:

The local lodge Secretary shall notify the District Secretary when the VASA VISITOR is received and when and where the Lodge receiving the VASA VISITOR will take it. The lodge receiving the VASA VISITOR shall take it to another lodge within six (6) months of its receipt.

Be it RESOLVED THAT Article 20 (b) of the District Lodge Golden Gate No. 12 By-Laws be amended to read:

The officers in the local lodges shall serve the term for which they have been elected.

Motivation: This resolution will make the By-Laws of the District Lodge Golden Gate No. 12 consistent with the Constitution of the Grand Lodge. As the By-Laws currently stand the term of January 1st to December 31st does not take into account the fact that most installations of local lodge officers take place after January 1st.

Section (b) no. 5 - The highest qualified candidate will be awarded the sum of five hundred dollars (\$500.00) as a scholarship, which shall be payable to a college, university, or vocational school of the candidate choice.

Motivation: Vasa members entering or enrolled in institutions of higher learning should be eligible for a scholarship in addition to members who are just graduating from high school. Funds are available in the scholarship fund to support passage of this resolution and this would involve no increase in assessments.

Motivation: The District Chaplain is an office which serves the District only during the opening and closing of official District meetings. This resolution would eliminate the elected office of District Chaplain, thereby saving time during the election of officers at the annual meeting.
