CHAIRMAN'S MESSAGE

There was a good turnout for our "Artsoppa och Pannkakor" supper. Many thanks to our pea soup cooks Birgitta Anderson and Alice and Ted Olson. We would like to have other people get their recipe and be cooks for next year. And thanks to all the people who helped in the kitchen.

Terry Tillman will be reporting about the Camellia Festival and Muriel Hjersman and Ellen Harrod about the Scandinavian Festival. They would like to have members donate craft items to be sold. There are so many good Scandinavian recipes for baked goods that we should be receiving lots to sell.

The executive board had a meeting on March 16, 1991, to discuss some business so that the regular meetings would not be so long. We feel that this will be helpful to eliminate some preliminary steps before presenting the agenda to the members.

Let's have everyone come to celebrate Monitor's 79th anniversary.

In Truth and Unity Myrtle Widmark The primary source of information, however, was "Checklist of the World's Birds" by Gruson. For each bird species it lists the major geographic region where it occurs. A list was compiled which was then checked with names of Swedish birds in "Fåglar, en Fälthandbok", by Björn Ursing. The list of Swedish bird names was then checked, via the scientific names, with Udvardy and "Birds of North America" by Robbins, Brunn, and Zim, one of the Golden Press series. Using the habitat classes employed by Udvardy, the Swedish bird names were listed first, then the scientific name (the binomial system derived by the Swedish botanist Carl von Linne'), the American name, the family name, and short comments as to the distribution of the birds in North America. There is a separate listing of rare or accidental bird species.

While most of the birds listed actually do visit both Sweden and North America, a few have been actually introduced, such as the Starling and the House Sparrow; escaped from confinement; or may have been driven to either area by a storm or carried by a ship. One of the strangest of these instances has been the establishment of the Ring-necked Dove in a relatively small area in the city of Los Angeles. While this is of a different species than the Swedish "Turkduva", they certainly are near look-alikes. In Sweden, however, it has been seen from Skåne to Uppland. Both originate from southern Asia, undoubtedly from caged pet birds. Also, there are instances of birds sharing the same scientific name, but having different living styles. The Common Magpie (Skata), east of the Sierra Nevada, tends to keep away from humans, while in Northern Finland it tends to live in human settlements. Normally it nests fairly close to the ground, but in Hungary it nests in the top of the tallest trees. This has undoubtedly resulted from a bounty being imposed on them because they damage broods of game birds.

THERE'S A BIRD WE HAD IN SWEDEN!



When I visited Sweden in 1980, my stay was from "Midsommar" until the middle of August. Much of my spare time was spent in walking in parks, the Uppsala city forest, or crossing the campus of Uppsala University. I was impressed by the colorful variety of birds seen, most of which were strange to me. On the other hand, the Raven looked just like the Raven I see in California, Nevada, and up the western coast into British Columbia. Then. I saw one or two Canada geese accompanying other geese grazing on the lawn at Skansen in Stockholm. Another time I saw what was undoubtedly a Magpie, but not the yellow-billed variety we have in the Central Valley of California.

I seemed to me that Swedes in North America might be interested to learn that more than 130 species of birds occurring in Sweden also occur in North America. Common names of birds usually are not translatable to the names used in another country. Who could tell, for example, that a "prutgås" is called a Brant in North America? What they do have in common is their scientific name, Branta bernicla, in this instance. Dr. Udvary's "The Audubon Society Field Guide to North American Birds, Western Region" made an excellent beginning for it includes some information of wider distribution of birds than the title indicates.

THE SWEDE BOY FROM GALESBURG

It was on January 6, 1878 that a son was born to August and Clara Sandberg in their home in Galesburg, Illinois. He was delivered by a Swedish midwife, the Swedish immigrant parents regularly spoke Swedish and Swedish was the first language that struck the ears of the new born. He was christened Carl August Sandberg by a minister of the Swedish Lutheran Church.

As with many other Swedish immigrants in communities with an immigrant population, much of the social life revolved around relatives and other Swedish families and the Lutheran Church with services in Swedish. However, there was little time for social life. August worked ten hours a day, six days a week, as a blacksmith helper at the Chicago, Burlington and Quincy railroad shops. His pay was fourteen cents an hour. On his take home pay of thirty five dollars a month he supported a family of seven.

Young Carl knew they were not poor. His parents never regarded themselves as poor but he knew they were not rich. Carl began making his contribution to the family at age eleven. He delivered handbills, had a newspaper route, worked as an office boy, delivered milk, shined shoes in a barbershop, worked as a helper in an ice house, a boat house, a pottery, at a race track, and as a water boy for threshing crews.

When his brothers and sisters could contribute to the family Carl took to the road as a hobo. He rode boxcars as far west as the Rockies working as a dishwasher, threshing hand, railroad track worker, fruit picker and wood chopper. Eventually homesickness directed his way back to Galesburg. The Spanish-American War began and he enlisted in the Sixth Infantry Regiment of the Illinois Volunteers. His unit went to Puerto Rico. They faced no enemy other than mosquitoes but suffered the hardship of monotonous food and heavy woolen uniforms in the tropics.

Resolution No. VI.

Be It RESOLVED THAT the District Lodge Golden Gate No. 12 bestow the Title of Honorary Life Member upon Past District Master Jessie Olsson.

Motivation: Sr. Jessie Olsson is a 50-year member of Jenny Lind Lodge and District Lodge Golden Gate No. 12. She has served the District in many offices. She held the Office of Treasurer for many years, before being elected to the Office of Secretary, holding that office also for several years.

Her dedication to Vasa and the District Lodge can be truly appreciated by any member who has been elected to and served in the Office of Secretary or Treasurer of the District Lodge, for the responsibility and time demanded by the nature of the offices.

In 1981 she accepted nomination and was elected to the Office of Vice District Master, and went on to serve as District Master in 1982-83.

She has served as Sweden Day Parade Marshall. At the 1986 Grand Lodge Convention held in New York, Sr. Jessie represented District Lodge Golden Gate No. 12 as a duly elected Delegate to the Convention.

Her service and dedication to Vasa is prominent. She has willingly accepted the Office of Treasurer for the Golden Gate Resort Center and also serves as Treasurer of the Past District Masters Club. She has accepted numerous appointed offices, having served as the first District Scholarship Chairman.

The Honor of a Life Membership in the District Lodge Golden Gate No. 12, is most deserved by such a dedicated lady, Sr. Jessie Olsson.

Resolution No. I.

Article 4 - Membership

a) The active membership of the District Lodge shall consist of its Officers, the Executive Board, Trustees, Auditors, all Past District Masters, District Supervisor of Children's Clubs, Vasa Star Correspondent and Publicity Director, District Membership Chairman, District Historian, District Blood Bank Chairman, Duly elected Delegates from the Various Local Lodges of the District and District Lodge Honorary Life Members.

Be It RESOLVED THAT Article 4, Membership (a) of the District Lodge Golden Gate No. 12 by-laws, be amended to read as follows:

a) The active membership of the District Lodge shall consist of its Officers, the Executive Board, Trustees, Auditors, all Past District Masters, District Supervisor of Children's Clubs, Vasa Star Correspondent and Publicity Chairman, District Historian, District Blood Bank Chairman, District Scholarship Chairman, duly elected Delegates from the various Local Lodges of the District and District Lodge Honorary Life Members.

Motivation: Since the District Lodge Golden Gate No. 12 adopted the Resolution to sponsor a scholarship funded from the District General Fund, a Chairman of the Scholarship Committee has been appointed, and rightfully should be included as an active member of the District Lodge as are the other Appointed Officers of the District Lodge.

Resolution No. II

Article 15 - Traveling Expenses

Delete the entire paragraph (a).

- b) The Trustees and Auditors shall be elected by a majority vote.

c) The election of the Trustees and Auditors shall take place immediately after the election of the District Cultural Leader.

Be It RESOLVED THAT Article 11, Trustees and Auditors of the by-laws of the District Lodge Golden Gate No. 12 shall be amended to read as follows:

- a) There shall be three (3) Trustees and three (3) Auditors for the District Lodge one (1) Auditor shall be elected yearly for a term of three (3) years. The Office of the Trustee for the three (3) year term shall be filled automatically by the out-going Jr. Past District Master. The Trustee and Auditor who has seniority of the body shall serve as Chairman of the Trustees and Auditors, respectively, and any unfilled term of the Auditors shall be elected first.
- b) The Auditors shall be elected by a majority vote.
- c) The election of the Auditors shall take place immediately after the election of the District Cultural Leader.

Motivation: The Office of District Trustee should be held by a person with great experience and knowledge of the operation of District functions. Who, other that the Jr. Past District Master is better qualified and more knowledgeable of the needs and functions of the District? The automatic succession of the Jr. Past District Master to the Office of the Trustee three (3) year term would also expedite the election of the Officers.


